In our continued effort to provide the highest standards of service and clinical care for women's services, we are pleased to announce the integration of the Departments of Gynecology and Obstetrics (GYN/OB) at The Johns Hopkins Hospital and Johns Hopkins Bayview Medical Center into one clinical department.
